#### **OPPORTUNITIES FOR ENGAGEMENT**

ND Department of Health and Human Services seeks public comment on an amendment to the Medicaid 1915(c) Children with Medically Fragile Needs Home and Community Based Services (HCBS) Waiver changing the age limit to 21. It currently provides services to children between the ages of 3 to 18 who are medically fragile. The goal of this waiver is to assist families in keeping their child home instead of having to place them in a nursing home or hospital to receive needed care. Submit comments by July 27. The ND Olmstead Commission invites you to apply to be a member of the Olmstead Commission Advisory Council, to increase the voice and involvement of individuals with lived experience in Olmstead Commission work. The Advisory Council will meet quarterly, between Olmstead Commission meetings. To apply, go to olmstead.nd.gov.
